## **Process for Conducting a Tree Farm Inspection**

|       | charges \$350 for 5 years of certification. Grant funding is available for a limited time to pay \$150 of the fee in all 100 counties. There is no application process for the grant.  |
|       | offers discounts to landowners with multiple Tree Farms enrolled in the program. Starting in 2023, Tree Farmers who have certified one Tree Farm (the primary Tree Farm) at the \$350 rate (less available grant funding) can certify new Tree Farms and recertify existing Tree Farms under the same ownership for \$100 each as long as the primary Tree Farm remains certified. The primary Tree Farm will recertify at the \$350 rate and the secondary Tree Farm(s) will recertify at the \$100 rate every five years thereafter. Tree Farms receiving the \$100 rate are not eligible for grant funding toward the certification fee. Contact the NCTFP to find out if a property qualifies for the discounted rate. |

|        | walks the property to determine if conditions on the ground align with the management plan and maps and meet the requirements of the Standards. If there are discrepancies between the plan, maps and on-site conditions, inspector works with the landowner to update or correct the information in the forest management plan per the NCTFP Forest Management Plan Policy. |
|        | notes the conditions and recommended corrective actions on the inspection form and shares this information with the landowner if conditions on the ground do not comply with the Standards. Inspector does not certify or recertify the property until all non-compliances are corrected.  |
